# 2024 Destination Elopement (Oregon)

Includes the officiant/celebrant's day-of professional appearance fee to legally officiate a 15 to 20-minute simple elopement ceremony on the Southern Oregon Coast, Central Oregon, the Northern California Redwoods, or any other adventure destination outside of Southern Oregon; limited availability.

## Package includes

- A complimentary initial intake phone call
- Unlimited pre-ceremony consultations with the officiant/celebrant
- The officiant/celebrant scouting out a location the day before based on the couple's interests
- The officiant/celebrant creating personalized vows or the officiant/celebrant's assistance in writing vows
- The officiant/celebrant providing a draft copy of the ceremony in advance to check for accuracy
- The officiant/celebrant handling the vital statistics marriage license clerical paperwork required by the State of Oregon after the ceremony

NOTE: Does not include any fees or permits that may be required. Rates subject to change based on destination. May include up to one hour of officiant/celebrant's hiking time if arrangements are made in advance.
