## *Additional Information*

### EVENT MINIMUMS:

Event minimum shall apply for private events in Grant's.

Events taking Monday through Thursday shall require a total event minimum of \$4,000. Events taking place Weekends, Holidays, and Fall Foliage shall require the total event minimum of \$5,000.

Event minimum totals can include the site fee and shall exclude tax and gratuity.

### PRICING:

All charges are subject to Vermont State Meals & Rooms tax (9%), Vermont State Alcohol Tax (10%), Local Stowe Tax (1%) and Gratuity (20%). A 20% surcharge will be added to all event rentals (tent, chairs, etc.). All prices are subject to change. Food and beverage prices will be guaranteed 60 days prior to the function.

Any event over 120 people may require off-site parking and shuttle service. Any event hosted outdoors may require an outdoor temporary toilet and handwashing station to be rented and set up nearby. These additional services may be subject to additional fees which may be discussed upfront at time of initial booking and collection of deposit.

### DEPOSITS:

A non-refundable deposit equivalent to 25% of the estimated function cost is necessary to reserve the date and location of your function. Another 25% is due 90 days prior and full payment of the remaining estimated balance of the function cost is required 30 days in advance of the function with any remaining actual balance due on the day of the function.

### SETUP:

The setup, delivery and breakdown/cleanup of non-hotel materials, or labor required above and beyond standard wedding or party setup is subject to a fee of \$25 per hour, per staff person (minimum of \$100). In most situations, The Stowe Village Inn requires that all events end at or by 9:00 pm or 11:00 pm; subject to date and other factors.

## GUARANTEE POLICY:

Two weeks prior to the event, all menus are finalized and any final counts on multiple choice menus are required at this time. If no guarantee counts are provided, the original estimate will be used for billing. We are prepared to serve 5% over the final guarantee number. All charges will be based upon the greater of the final guarantee or the actual number of guests served.

## CANCELLATIONS:

In the event that your function is cancelled, the following policies will apply: cancellations occurring after signing the Event Agreement will result in the forfeiture of the initial deposit. Cancellations occurring over 90 days prior to the wedding function will result in the forfeiture of 25% of the estimated cost of the function. Cancellations occurring between 90 days and 20 days prior to the wedding function will result in the forfeiture of 50% of the estimated cost of the function. Cancellations occurring between 20 and 7 days to the wedding function will result in the forfeiture of 75% of the total estimated cost of the function. Cancellations occurring within 7 days of the function will result in the forfeiture of 100% of the total estimated cost of the function.

## THE FINE PRINT:

- All food and drink items must be prepared and served at The Stowe Village Inn with exception of the wedding cake which must be purchased from professional kitchen or bakery.
- Any excess food and drink item may not be removed from the function.
- The Stowe Village Inn reserves the right to move assigned function rooms. If a change from the original set-up is requested on the day of the function, an additional labor charge may be incurred.
- The Stowe Village Inn is not responsible for any items brought on property on behalf of the bridal party by an outside vendor.
- The Stowe Village Inn is not responsible for setting up, breaking down or moving items from outside vendors, unless it is preauthorized in writing. Additional coordination fees may be incurred.
- The Stowe Village Inn does not assume liability for any materials or equipment that are damaged or lost when left at our facilities prior to, during or after a function.
- The guest is responsible and shall reimburse The Stowe Village Inn for any damage, loss or liability incurred by The Stowe Village Inn by any of the customer's guests or any persons or organizations contracted by the customer to provide any service or goods before, during or after the function.
